Annual Elections

New Judging Guide

The long awaited 1984-86 Corvette Technical Information Manual and Judging Guide is now in print and for those who've been itching to have your early C4 Corvette join the Flight Judging corral, the time has arrived! If you've kept your eye on the front 'credit' section of *The Corvette Restorer* magazine, you should have noticed the appointment of Vito Cimilluca as 1984-86 National Team Leader. My read of

the TIM & JG says Vito has done an EXCELLENT job with his team in putting together this first edition of the JG book. It's packed with

information more typical of a 2nd or 3rd edition JG book!

1963-64 Judging Updates

Errata have been released for the 1963-64 JG book. Four clarifications, two in the Mechanical section and two in the Chassis section, have been released. For those who wish to update your JG books, the updates are:

(1) Mechanical, Section 14, Alternator, Sub-Section: Mounting & Adjusting Brackets

In the right-hand mount text, ninth sentence, replace

"...with a thick flat washer, star lock washer..."

With

"...with a thick, flat washer, lock washer..."

"The adjusting bracket curves over the top of the alternator where it is secured to the alternator front plate with a thick, flat washer, lock washer, and a cadmium or since plated hex-head bolt which threads into the alternator."

(2) Mechanical, Section 17, Heater or Air Conditioning System, Sub-Section: Hoses, Pipes, Clamps and Grommets

In the second paragraph, second sentence, replace

"...supplier ID's are 'GY', 'RDD' and..."

With

"...supplier ID's are 'GY', 'RRD' and..."

(3) Chassis, Section 1, Brake System, Sub-Section: Power Brake Booster & Hose.

In the first paragraph, third sentence, replace

"...and '4310' for 1964 models..."

With

"...and '4310' or '4311' for 1964 models..."

(4) Chassis, Section 7, Front Suspension, Sub-Section: Knuckles, Spindles, Arms and Brake Assemblies.

In the last sentence of the Brake Assemblies paragraph replace

"The J56..."
With
"The J65..."

Flight Score Sheet Resource

Several years ago, Flight Score Sheets were removed from our JG books. This was done to allow the National Judging Chairman to change and 'rationalize' points allocated to specific judging items with minimal obsolescence impact on already published JG books in inventory for sale.

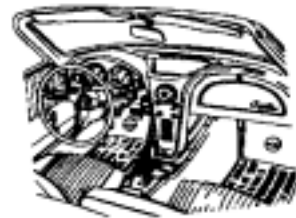
When this change happened, NCRS members wanting a current copy of a given Flight Score Sheet have had to request it from the National Judging Chairman. Requested copies have always been sent without charge. Today, most of the changes have been made and our Flight Score Sheets are rather stable.

Still, each time we conduct a judging meet, we need to arrange in advance for a sufficient number of current copies of the score sheets. This has a few drawbacks. Cars can be accepted at the last minute for Flight Judging. Paperwork sometimes has a nasty habit of growing legs and walking away on the judging field! This can create problems.

Recently, Roy Sinor (NCRS National Judging Chairman) made available to each local Chapter Judging Chairman a full set of our current Flight Score Sheets in computer format for on-demand printing/viewing. These are in Adobe Acrobat Reader format making them independent of individual PC/printer considerations. This is the same method we use to distribute our Chapter Newsletter via internet/e-mail.

My office now has the ability to generate a facsimile of Flight Score Sheets. But, it's not that easy to make them available to the membership. First, each section of the score sheet (Score Summary, Operations, Interior, Exterior, Mechanical, and Chassis) is a separate Adobe (.PDF) file that ranges in size from 100-300 KB. It was done that way to ease Roy's job and make changes to an individual line item or scoring section simple.

Since our website is open to the general public, these files can't be posted for general download (must be an NCRS member to obtain). But, I've packed the individual sections into an automatically exploding ZIP archive (runs 800-1400 KB in file size) and I now DO have the ability to transmit a copy via e-mail attachment to requesting RMC members!

The Montana Road Trip

Last November our Chapter was invited to the Big Sky Corvette Club (NCCC) annual meet at Billings, Montana. Sondra Schlaht, a member of our Chapter and our contact in Billings, extended the invitation. We had 7 members' sign up and 6 make the trip with Jim and Lori changing plans at the last minute for a drag racing invitation in Kansas. Jon Whiteley, Rick Reiff and son Jared, Steve and Debbie Beatty,

Fred and Kathy Koenig, Ralph and Sharon Ridge, and Shirley and I made the trip.

We met at the Cracker Barrel in Loveland to confirm our route and headed north. The trip was uneventful until we stopped just 36 miles south of Douglas, Wyoming. When we started back on to the highway, Steve Beatty's '66 gave up. The problem was a dead fuel pump. Steve called AAA and was flat bedded into Douglas to the Chevy dealer. We were told no one in Douglas could work on the car until Thursday, but they did have a fuel pump. Steve bought the pump, we went to lunch, and prepared for the task of changing the pump ourselves. The Chevy dealer offered any tools we might need, but we had enough tools to rebuild a Corvette amongst our group. So, behind the dealer on a hot asphalt drive we replaced the fuel pump. While I did the mechanical stuff, the others assisted by handing me tools and looking at the '58 restoration the body shop had underway at the dealer. There were a couple other neat Chevys that I would have wanted, a '67 BB Malibu and a Z06 on the show room floor.

By around 3:30 p.m. we were back on the road to Cody, our first overnight stop. We were just about there and Rick Reiff started to experience some oil pressure fluctuation in his '72 383ci small block. We pressed on to Cody and talked about it over dinner that evening. The decision was to make the 108 miles into Billings and then see what was wrong with the engine.

Friday morning was spent in the Buffalo Bill Museum. What a great place if you like the West and the history of the Plains Indians and guns. This Museum has the largest collection of guns and special gun collections in the West. This year they are displaying the largest ever Colt Collection. We hit it right for Fred and I. We could have stayed there a week.

By 2:00pm we were headed north to Billings. Ralph was in the lead Corvette with Myrtle (a satellite-tracking device) at the guide. The next thing you know we are headed out into the country towards some dirt roads. My map program was catching some comments on the

first leg of the trip but aside from construction dirt, I did not guide us to dirt roads. Ralph did a "reset" on Myrtle and she re-addressed the plan and again headed us north.

We arrived in Billings just at the right time. We were the first to register and there when the first keg was tapped. This event was planned around fun, food and drink. NCCC events balance these three very well. You have fun with your Corvette all day long. At 5:00 p.m. the keg is tapped and at 7:00 p.m. the food is on the table. It's all you can eat and drink, within reason of course. I think I only gained 10 pounds on this trip in 5 days. Now I'd like to lose it.

Rick's '72 engine was a problem. After pulling the valve covers, he learned the number 2 and 4 cylinders were the problem. Number 2 had a broken rocker stud and pushrod and a bent pushrod. Number 4 had a flat cam lobe. On top of that there was no oil coming to the rockers. Major problem, of course. We did not have the tools to do this job, so Rick would have to leave the car and make a trip back to Billings.

After the loads of Corvettes, fun, food and drink, it was time to press on home on Monday morning. The problem was to get Rick and Jared back to Denver. By chance I had spoken with Sondra on Sunday evening, and she mentioned that Bill Beamer from Aurora would like to join our caravan back. We welcomed his company. This also afforded a ride for Rick and Jared. Rick could ride with Bill and Jon Whiteley agreed to adjust his seating for Jared. Problem solved. Rick took the time with Bill to explain the virtues of the RMC and enlist Bill's future membership.

The trip back was going along very well. No problems through Montana with exception of some low fuel before we got to Sheridan, Wyoming, our scheduled stop. We pulled off at Wyloa for fuel and the necessary stop. Our next stop was near Kaycee, Wyoming then to

Casper for lunch. Steve was a bit concerned when we went by Douglas thinking his '66 would want another fuel pump but that did not happen.

Fred and Kathy would be the first to leave the caravan at Loveland. We thought everything was going well at the time but had lost contact with Steve and Debbie at about the same time near mile marker 250. Since traffic was heavy and we were at the end of the trip, everyone pressed on towards their homes. Jon and Bill were dropping Rick and Jared at the Cracker Barrel at 120th Ave. where Daphyne would pick them up.

The following Friday, late evening, I received a call from Steve. He and Debbie were involved in an accident, which totaled their '66 Corvette just after passing the Berthoud exit. They received some cuts and bruises and a few cracked bones but were very lucky to be alive. You can see their Corvette on our web page (NCRSRMC.org). The insurance company gave Steve the option to buy the car back. He is planning on rebuilding it with a little (a lot) of help from his friends.

This trip was a lot of fun, but also a lot of tragedy. Fortunately, Steve and Debbie will heal and be as good as they were before the accident. Their Corvette can also be fixed. Rick is working on his engine and we hope to have a report on it by our next meeting July 19th. This was a real experience. We are prepared to have a good time with our Corvettes and will be working on a way to prevent what happened for future Road Tours we plan.

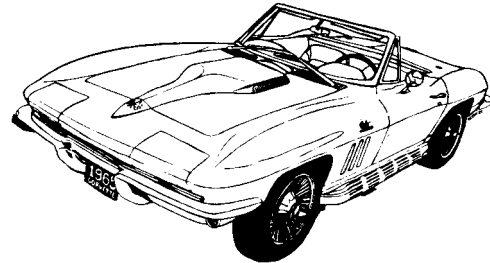
